

**Cricket Feet Casting Actors Showcase
Call for Comedic Writers**

In April 2007, the Cricket Feet Casting Actors Showcase launched with a cast of 35 actors in 17 comedic scenes. Representatives from agencies, management firms, and casting offices filled the Promenade Playhouse for three nights of fast-paced laughs (and dinner and drinks too)!



For our July 2007 showcase, we decided we wanted to use *all original material* rather than the combination of original and road-tested comedic scenes we produced our first time out. This turned out to be not only a huge success but also a wonderful opportunity for our writers—whose talents were showcased right along with our 32 fabulous actors' comedic skills!

So, we did it again for our November 2007 showcase and into our 2008 showcases in our new, stunning venue (the Colony Theatre), and we've now become known for showcasing amazing, comedic actors *and* top writers of comedic scenes! We're maintaining an open, ongoing call for comedic writers to submit original material from here on out. Yippee! We are specifically seeking two-person comedic scenes that come in at around four-minutes. We are not offering any pay at this point, but you do retain all rights to your original material and may feel free to sell and resell it to as many buyers as you can find! (Meanwhile, if you do happen to hear from a literary agent or other cool industry contact who saw your work at our showcase, we do hope you'll let us know, so we can celebrate with you!)

Please note: All submissions MUST be accompanied by this two-page writers' release. DEADLINE for scene submissions for the current showcase period are posted at the WRITER FAQ page of the Cricket Feet Showcase Website. Material received after the deadline posted on the website will be held for future showcase consideration.

MATERIAL RELEASE

1. _____ (the "Grantor") grants to CRICKET FEET, INC., the non-exclusive right to produce a showcase scene (the "Showcase Scene") based upon the material currently entitled " _____ " (the "Work") written by _____, attached hereto, and to publicly perform, distribute, exhibit, or exploit said Showcase Scene in all media now known or hereafter devised, by any title, in perpetuity, and throughout the universe. Grantor hereby grants to Cricket Feet, Inc., any further rights, under copyright or otherwise, which Cricket Feet, Inc., may need to effectuate the above made grant, including but not limited to all rights necessary to adapt the Work for the Showcase Scene and to use the name of the author in connection with the exploitation of the Showcase Scene.

2. Grantor warrants the Grantor is the sole owner of all rights of copyright or otherwise in the Work, and that Grantor has the full and sole right and authority to convey the same; that the Work is wholly original with Grantor and that Grantor is the author thereof; that neither any incident contained in the Work nor any part thereof was taken from or based upon any other literary, dramatic or musical material; that the exercise or use of any of the rights herein granted will not in any way infringe upon or violate any rights of any person, firm or corporation whatsoever, including but not limited to rights of privacy and publicity; that the rights herein granted are free and clear of any litigation pending and are not encumbered in any way that would interfere with Cricket Feet, Inc.'s full enjoyment of any rights granted herein; and that Grantor shall not do any future act which will or may impair Cricket Feet, Inc.'s full enjoyment of any rights granted herein.

3. Grantor agrees that Cricket Feet, Inc., and any of its licensees or assigns shall have no obligation to pay any monies in respect to the exploitation of the Work hereunder. Nothing herein shall require Cricket Feet, Inc., to promote, distribute, or otherwise exploit the Showcase Scene. Cricket Feet, Inc., has made no representation or warranty of the manner in which the Work will be used and nothing will require the Work's use at all.

4. Grantor agrees that the rights granted hereby shall commence when the Grantor executes this Agreement.

5. Grantor acknowledges that Cricket Feet, Inc., will incur expense and undertake commitments and otherwise proceed in express reliance on this Agreement and rights hereunder.

6. Grantor agrees to indemnify and hold Cricket Feet, Inc., and Cricket Feet, Inc.'s successors, licensees and assigns free and harmless from any and all claims, liabilities, costs, losses, damages, or expenses including but not limited to all attorney's fees and costs reasonably incurred in connection therewith, which in any way result from or arise out of any breach or alleged breach or failure of any covenant and warranty of Grantor contained in this Agreement.

7. This Agreement shall be governed by the laws of the State of California applicable to agreements executed and to be wholly performed therein. Grantor agrees that this document constitutes the entire agreement between the parties superseding any previous agreements written or oral. Grantor further agrees that any modification must be in writing and signed by both parties hereto.

8. This Agreement shall inure to the benefit of and be binding upon the parties hereto, their respective successors, assigns, next of kin, heirs, administrators, executors, officers, and agents, as the case may be.
