This turned out to be not only a huge success but also a wonderful opportunity for our writers—whose talents were showcased right along with our fabulous actors' comedic skills! We've grown as a showcase, having featured 211 actors in seven showcases produced in 2007, 2008, and 2009, and we now fill the stunning Colony Theatre with an overflowing audience of excited industry and fans alike.

So, as we now return after a hiatus to produce our *fourth year* of showcases, we're thrilled to continue featuring amazing, original comedic material, as well as our fantastically talented actors of course! Therefore, we're maintaining an open, ongoing call for comedic writers to submit original material. Yippee!

We are seeking two-person comedic scenes that come in at around four minutes. We're not offering any pay but you retain all rights to your original material and are free to sell it to as many buyers as you can find! Meanwhile, if you happen to hear from a literary agent or other industry contact who saw your work at our showcase, we hope you'll let us know so we can celebrate you!
